Students have the entire semester to complete the eLearn CCI (Condensed Curriculum, International, Inc.) Medical Billing & Coding course.

CCI uses e-texts for the Medical Terminology portion of training. Training is through *Get Connected*.

Students will be mailed the *CPT Plus* and *ICD 10* official codebooks with guidelines however learning is self-directed through the Online Learning tool used by CCI.

Students move through the programs at their own pace and receive support from CCI through emails, phone and chat tickets 9 am through 10 pm.
